## NEW TRENDS IN THE WORLD OF BEAUTY AND LEGAL REGULATION

**Аннотация**: в статье освещены новые тенденции в индустрии красоты, приведен краткий анализ косметических процедур по восстановлению волос, изучено правовое регулирование оказания услуг.

**Abstract**: the article explores new trends in the beauty industry, provides a brief analysis of cosmetic procedures for hair restoration, and examines the legal norms of consumer services.

Since ancient times, hair was considered one of the most precious treasures of a woman. The very first hairdressers and experts in the field of women's beauty tire-lessly developed masks, balms and much more, and all for the sake of beauty remained beautiful and pleased others with their beauty. Every woman's dream is to have thick, lush, silky hair. But to make this dream come true, you need to take care of them daily and very carefully. Here is one example of how to maintain this beauty due to collagen hair restoration. Collagen hair wrap is a procedure with which you can tighten the structure of the hair and protect it from negative effects. It helps to cope with the following problems: tangled hair, pointed tips, dull tint, lack of elasticity [7].

It is worth noting that collagen hair restoration, namely the composition of Fasion Hair Expert PrX is considered a cosmetic procedure; it is similar to cold botox and is often confused with keratin straightening. To prolong hair care after the procedure it is recommended to follow the rules: comb your hair very well before washing; before applying the shampoo to your hair, rub it in your hands and apply the resulting foam to wet hair; blot wet hair with a towel; optimal combination — hair washing and scalp massage; dry your hair in natural conditions, limit the use of a hair dryer; hair should be combed every day; hair loves the sun and air, so walk more; do not overuse perming and hair coloring; do not allow your head to overheat in the sun or cool down in the cold [9, c. 31–37].

To describe this method in other words, you need to give one example similar to collagen recovery, it's cold botox. Cold Botox is used to strengthen, nourish and stabilize the hair structure. This procedure is considered more popular today. The result is visible immediately. Curls become moisturized and smooth [5]. To complete the procedure you need different appliances: a peignoir, bowl, silicone brush, towel, hair dryer, comb, hairdresser clips, a special composition. There are no contraindications for collagen recovery. This procedure is done when the hair is damaged, dry and burned. This procedure did not exist earlier; it appeared not so long ago. Due to the simplicity and ease of use, as well as excellent results, it is expected that in future this procedure will be in demand among customers.

Providing hairdressing services must also meet the requirements of SanPiN 2.1.2.2631–10 «Sanitary and epidemiological requirements for the placement, device, equipment, content and mode of operation of organizations of public utility, providing hairdressing and cosmetic services». Paragraph 1.6 states that it is allowed to use, store and sell to visitors of organizations of public utility that provide hairdressing and cosmetic services, perfumes and cosmetics, and hair, nail, and skin care products that have documents confirming the safety of the products used in ac-

cordance with the established procedure [4]. Failure by the contractor to comply with its obligations under Rules No 1025 in terms of not communicating to consumers the necessary and reliable information about the services provided may become the basis for bringing the contractor to administrative responsibility [3].

The beauty industry does not stand still, every year conquering new frontiers. It is expected that the most popular services of beauty salons in the world will be hair styling and coloring, head massage and individual treatments for the scalp. Such areas as hair curling services, chemical hair straightening and a range of keratin smoothing procedures will be a priority in this area and will set the trend in Russia and abroad in 2019–2020 [1].
